Several of our chapter leaders took the opportunity on the first Saturday of November to meet in Cincinnati with other state and regional AFA leaders, as well as AFA national president, Bob Largent, and AEF national president, Mary

Anne Thompson. Not surprisingly, the call to action from our national AFA leaders is the same message we are already moving on!

Our first task is to grow our leadership base. The only way an organization can continue long-term sustainment is to have in place a deep and qualified pool of leaders who can step in at any time and move the organization forward. Our leadership team needs to identify those who will replace them, not just in terms of a single name, but a group of two or three or four that they personally mentor and grow. Our chapter's involvement with the Visions Program that provides newspaper resources directly into 159 area classrooms, is the third largest in the country, and our support of WPAFB educational outreach activities, such as the Wizards of Wright and teacher-in-service days, is wonderful. However, even our sterling programs can become better through your personal involvement. Please contact Sheila Wallace to find out how we can tap your talents and abilities to support this important mission. Additionally, take the time to let educators in the schools around you know that we have resources to help them.

Finally, we must take on the task of being advocates for aerospace – and the Wright Memorial Chapter does this exceedingly well. Part of this is through our involvement with other AFA chapters and AFA national in developing a statement of policy and top issues that are important for the Air Force and Wright-Patterson. We, individually and as an AFA, can be advocates with our Congressional delegations in ways that those wearing a blue suit cannot, taking the message of important issues directly to our elected representatives – a great example is the Call to Action request to each of you (with an e-mail address) from AFA national regarding the stalled FY2006 Defense Authorization bill (I hope you have already contacted both Ohio Senators!). We are also advocates with the local community on issues that mutually affect both the local business/community environment and WPAFB. Our Community Partners programs and the great relationship we have with the Dayton and Miami Valley leadership community enhance this aspect of our mission, but can be further strengthened through your active involvement. If you have a desire, a skill, or specific interest here, please let John McCance, Kent Owsley, or myself know, so we can link you with the right folks.

I continue to be impressed and delighted with the efforts of this chapter. We must lead and grow as we educate and advocate for our current and future Air Force and the Air Force Association. I look forward to working and talking with you about the vision of our continuing success.

afa21 Task Force Status Report

November 2005

The *afa21* Task Force has begun its second year of activities and looks forward to evaluating new ideas and concepts that can benefit the Air Force Association and bringing them forward for review and consideration later in the year. Since the Board meetings and convention in September, the Task Force has been analyzing the outcome of the debate and vote on its first year recommendations and planning its approach and activities for the coming year. The Director wrote an article for *Air Force* magazine and *Newsline* summarizing the results of the recommended actions and outlining upcoming activities. That article is included in the November issues of those publications. In addition, the Task Force Leadership Team met in October to map out the next steps in the process and developed the following plan.

Tax Status Change Implementation

With the approval to move forward with the change in AFA's tax status, the Task Force has three major responsibilities to achieve implementation. The first is to monitor the status of the request to the Internal Revenue Service for a favorable ruling regarding the change. We have received a request for additional information from the IRS and responded promptly with all of the requested information. We have had no indication that any concerns exist and anticipate a favorable response, perhaps before the end of the calendar year. No action on the tax status change will be taken until a favorable IRS ruling is received.

The second responsibility is to develop a detailed implementation plan, including identification of the documents that will need to be created, revised and/or signed as well as the financial transactions that will need to be executed. This plan is currently under development and will be presented to the Transition Board for review and approval in February 2006.

The third responsibility is to work with the Constitution Committee to develop the Transition Constitution and governance procedures for the Transition Board during Phase 2 of the transition period. This is the period of time after the tax status change has been executed and AFA and AEF have been combined, but prior to approval and implementation of the permanent Governance structure. It is expected that this period will last from April 1, 2006 through September 30, 2006, but those dates could be adjusted based on the IRS approval status and when the permanent governance structure is approved. It is hoped that the Transition Constitution will be

ready for review and approval by the Transition Board in December 2005.

Governance Structure

The Task Force has two key responsibilities with regard to governance. The first is to develop the permanent governance structure to support the new organization that is created by the combination of AFA and AEF. This is the top priority for the Governance Team and will be worked between now and early January. The issues to be considered include the size of the Board, the officer structure, the new empowered councils, and the committee structure. It is anticipated that a final proposal will be presented to the Transition Board for review and approval in February 2006. With that approval, the Constitution Committee will be tasked to develop constitution and OPM changes for presentation to the Board and convention in September 2006 so that final approval of the permanent governance structure can be granted.

The second responsibility regarding governance is to further analyze the election process and the issues associated with it. Those include the member-based governance concept, the officer nomination process, and how elections should be conducted. A status report on these issues will be presented to the Transition Board in February 2006, and recommendations will be ready for consideration in September 2006.

Field Structure

The Field Structure Team will continue to evaluate the various concepts under consideration that will impact the field. These include combining the region and state management levels into a single level of management, revising chapter operating procedures, and revising the chapter financial support process. It is anticipated that a status report in these areas will be presented to the Transition Board in February 2006 and recommendations will be ready for consideration in September 2006.

The *afa21* Task Force Advisory Group and the Independent Review Team will both play a role in this year's process much like they did last year and we will continue to seek input from the entire Association regarding the concepts under consideration. As in the past, we will also keep everyone informed as we move forward. The Task Force thanks you for your interest and involvement in this very important initiative.

Speaking of Arnold Air Society . . .

A dramatic growth characterized the Arnold Air Society from its obscure beginning in the spring and summer of 1947. It tended to prove the ideals on which this organization was founded – namely, high moral, physical, and mental attitudes. These aims were molded in the formation of the society to help train future Air Force leaders.

At summer camp in 1947, a group of AFROTC cadets from Cincinnati, Ohio discussed the possibility of an honorary society and presented their idea to Captain Nolkamper. A committee of cadets was formed to write a constitution and to find a name. The name chosen in a unanimous decision was made to honor General H. H. Arnold, one of the greatest leaders in aviation history. The permission to use his name was granted in December of 1947, with the provision that the society begin on a local basis at the University of Cincinnati, with expansion of a spontaneous nature.

In April of 1948, the United States Air Force officially recognized the society. Shortly thereafter, the society became a project of the Air Defense Command, whose duty it was to see that the local group became nationalized. In September of 1948, the Air Defense Command sent copies of the society's constitution to all universities and colleges throughout the nation, with the hope of forming similar organizations. Within the next year, twenty new squadrons were formed.

Many new ideas came about in the early 1950s, one of these being the National Conclave. The conclave is used as a central means of determining the policies of the society. At the first National Conclave, at the University of Cincinnati, Mrs. H. H. Arnold was named Honorary Sponsor. That same year, the society officially became the "Arnold Air Society."

USA Today, Visions Program

Most of you have heard of the USA Today newspaper, but how many of you know that they have a program called Visions of Exploration: Past, Present, Future designed to be used in classrooms. To date, this 14-year program has reached more than 2,000,000 students and 1300 classrooms! This multi-disciplinary program, developed in partnership with NASA is made possible to schools all across the country by AFA chapters. The members of the Wright Memorial Chapter, should feel very proud to know that our chapter sponsors the 2nd largest number of classrooms in the country. This year we are sponsoring 159 classrooms, second only to Central Florida, in Orlando which sponsors 200 classrooms. Teachers began receiving their papers Tuesday, November 8th and they will receive 30 copies per week for the next eighteen weeks.



The Aerospace Education Foundation and the Air Force Association teamed up to provide the Visions of Exploration program designed to increase students understanding of science, math, social studies and aerospace technology. It prepares students for the increasingly competitive, complex and technology-based world beyond the classroom.



The Wright Memorial Chapter began by sponsoring 75 classrooms. The chapter, knowing the importance of our children's education, decided to raise the number of classrooms sponsored to 100. AT&T Government Solutions being one of the newest Wright Memorial Chapter Community Partners recognized the importance of supporting Wright-Patterson leadership in providing financial support to educational program such as the USA Today Visions and the Wright Patterson Education Outreach program as well as others across the Dayton community. Through the generosity of AT&T Government Solutions and the hard work of John McCance, Account Executive, Air Force Programs, we were able to receive a grant for \$5,000 thereby increasing our total to 159 classrooms.

The Wright Memorial Chapter sponsors classrooms in public and parochial schools, urban, suburban and rural districts throughout the Miami Valley and as far south as northern Cincinnati. Many of the teachers who have used this program from year to year tell us regularly how this program is a tremendous teaching tool in their classrooms. Their students are always excited to see Tuesday come, so they can have fun with their newspaper, and oh yes, keep their teachers happy by learning at the same time.

The reception was held on November 16th at the Wright Patt Club and Banquet Center with 67 community leaders in attendance to include City Managers, Mayors, City Council, Chambers of Commerce, politicians, local Department of Defense Industry and Wright Patterson military and civilian personnel. John McCance introduced the guests followed by presentations by each of the honorees on their experiences involving the Dayton Peace Accord.

Robbie Robinson, the Base Commander during the Accord meetings gave an overview of his involvement in selling the Team on having the negotiations at

Wright Patterson AFB and how his people had to modify facilities on an accelerated schedule. Ambassador Kornblum, the top negotiator for the Accord provided an insight on how the negotiations transpired and some of the hurdles they had to get over to finally compromise an agreement. Ambassador Frowick, responsible for executing the Accord Agreement, told of the problem and issues he had to overcome to successfully execute the agreement. The interchange gave those who attended a greater understanding and an appreciation of the complexity of the Accord Agreement.
